**CORRIGENDUM/ADDENDUM TO THE TENDER NOTICE
FOR HIRING OF VEHICLES FOR RAJYA SABHA TELEVISION,
NEW DELHI**

With reference to the tender notice No. RSTV/Admn/44(i)/ 2018 dated 08 November, 2018 for hiring of vehicles for Rajya Sabha Television, a pre-bid meeting was held on 15 November, 2018 at 3:00 p.m. in the office of RSTV at 3rd Floor of Talkatora Stadium Annexe Building. In pursuance of the pre bid meeting, following amendments are made to the tender notice:

(i) **Para 30 of the tender notice may be read as under:**

For The successful bidder will be required to provide requisite number of vehicles as specified in part ‘A’ and part ‘B’ of **Annexure-II**, as the case may be, within one month of issue of the work order.

Read The successful bidder will be required to provide requisite number of vehicles as specified in part ‘A’ and part ‘B’ of **Annexure-II**, as the case may be, within one month of issue of the work order. However, if the commercial registration of the vehicles specified in part ‘A’ and ‘B’ is not being allowed by the Government of NCT of Delhi till the time of execution of work order, successful bidder will be allowed to provide lower/ higher variants of the type of vehicles specified in part ‘A’ and part ‘B’ of **Annexure-II** whichever is being registered by the Government of NCT of Delhi for commercial use .

(ii) **A2 of Part ‘A’ of Annexure II of the tender notice may be read as under:**

For A2. FOR HIRING ON DAILY BASIS FOR OUTSTATION TRAVEL OTHER THAN PLACES GIVEN UNDER “B” ABOVE : 2015 MODEL

Read A3. FOR HIRING ON DAILY BASIS FOR OUTSTATION TRAVEL OTHER THAN PLACES GIVEN UNDER A2 OF PART ‘A’ : 2015 MODEL

(iii) **B3 of Part 'B' of Annexure II the tender notice may be read as under:**

For B3. FOR HIRING ON DAILY BASIS FOR OUTSTATION TRAVEL OTHER THAN PLACES GIVEN UNDER "B" ABOVE : 2018 MODEL

Read B3. FOR HIRING ON DAILY BASIS FOR OUTSTATION TRAVEL OTHER THAN PLACES GIVEN UNDER B2 OF PART 'B' : 2018 MODEL

(iv) **Para (c) of the certificate given in Annexure-II of the tender notice at page 15 may be read as under:**

For Vehicles hired on monthly basis may be used by RSTV to travel anywhere in the country. In that case, driver allowance and other allowances, if applicable, will be levied as per allowances applicable for hiring of outstation vehicles mentioned in Part C of the Financial Bid.

Read Vehicles hired on monthly basis may be used by RSTV to travel anywhere in the country. In that case, driver allowance and other allowances, if applicable, will be levied as per allowances applicable for hiring of outstation vehicles mentioned in A3 of Part 'A' and B3 of Part 'B' of Annexure-II (Financial Bid). The duty hours i.e. 11 hours per day multiplied by number of duty days or the actual duty hours during the outstation period, whichever is higher, will be admissible in case of those vehicles which are used for outstation duties from the monthly pool of vehicles as mentioned in A1 of part 'A' and B1 of part 'B' of Annexure-II (Financial Bid).

2. All other terms and conditions of the tender document shall remain unchanged.
