**CORRIGENDUM/ADDENDUM TO THE TENDER NOTICE FOR**  
**INTERNET CONNECTIVITY FOR RAJYA SABHA TELEVISION**

With reference to the tender notice No. RSTV/Admn/68/2018 dated 09 May 2018 for Internet connectivity for Rajya Sabha Television, a pre-bid meeting was held on 18 May 2018 at 4:00 P.M in the office of RSTV at 3<sup>rd</sup> Floor, Talkatora Stadium Annexe Building. In pursuance of the meeting, following amendments are made to the tender notice:

- (i) **Para 1 (c) at page No 1 may be read as under**  
ISP should have annual turnover of Rs.50 Crore or above during each of the financial years 2015-16 and 2016-17. **Attested copies of Income Tax Returns and Balance Sheets for these financial years should be enclosed with the technical bid.**
- (ii) **Para 1 (d) at page No 1 may be read as under**  
ISP should have provided similar service of value of Rs.25 lakhs or above to **at least two** Government organisations or PSUs or reputed MNCs or TV Channels during both the financial years **2015-16 and 2016-17**. Names and addresses of such organisations should be provided with the technical bid.
- (iii) **Para 3.1 on page no. 2 may be read as under:**  
**The successful bidder will have to complete the installation of requisite equipment and commencement of specified services within 45 days from issue of work order.** Time is the essence of the project and the service provider will have to stick to the prescribed schedule. Delay in commencement of services may result in a penalty @ 2% of the total contract amount per week of delay or part thereof, subject to a maximum of 10% of the total contract amount or as per the decision of Rajya Sabha Television
- (iv) **Last date for submission of Bids (ref para 4.1 at page no. 3) may be read as under**  
The last date for submission of bids stands **extended till 08 June 2018 by 05:00 pm.**
- (v) **Opening of Bids (ref para 6 at page no. 4) may be read as under**  
Technical Bids will be **opened at 04:00 pm on 14 June 2018** at RSTV Office, 3<sup>rd</sup> Floor, Talkatora Stadium Annexe Building, New Delhi.

(vi) **Annexure-I (Technical Bid) (ref pars 8 of technical bid) may be read as under**  
**Annual turnover for the following financial years:**

(vii) **Para 10 of technical bid may be read as under**
