**TENDER NOTICE FOR SUPPLY OF LED TELEVISION  
TO RAJYA SABHA TELEVISION (RSTV)**

Sealed tenders are invited under two bid system viz. **Technical Bid** and **Financial Bid** from manufacturers/ authorized distributors / dealers, hereinafter referred to as agency, for supply of LED Television to Rajya Sabha Television as per **Annexure-I**.

**2. ELIGIBILITY CONDITIONS**

- 2.1 The agency interested in applying should have Permanent Account Number (PAN) under the Income Tax Act, 1961. A copy of the PAN Card and GST Number should be enclosed with the Technical Bid.
- 2.2 If the Agency is a consortium, a copy of MOU between the partners should be submitted with the technical bid.
- 2.3 The Agency should not have been blacklisted by any government organisation/PSU in the past. A certificate to this effect should be enclosed with the technical bid.

**3. The agency while submitting its bid should keep following points in view:**

- 3.1 Item supplied should be of standard make and model. The model of the equipment should not be nearing obsolescence and should not be more than one year old since its launch in the open market.
- 3.2 The Agency shall provide comprehensive after sales services in India such as repairs, maintenance, supply of spare parts etc. and should be able to provide such service at short notice irrespective of the presence of it's after sales service centres in India at least for a period of five years. Agency shall be required to furnish a certificate to this effect.
- 3.3 The agency shall quote only for intended item and shall not quote for alternate item.
- 3.4 The Agency shall provide a comprehensive demonstration of the item to the professionals of RSTV to familiarise them with the operating aspects without any additional charges.

4. **GENERAL CONDITIONS.**

- 4.1 The agency will ensure that the item mentioned in **Annexure –I** is delivered within 2 weeks from the date of issue of purchase order in good and working condition. The item so delivered is to be supplied on site by the agency to the satisfaction of RSTV.
- 4.2 The item should be securely packed to withstand transportation risks and delivered in perfect condition.
- 4.3 The item shall be under warranty for a period of 12 months from the date of its delivery to RSTV. The Agency will be responsible to fulfil the guarantee/warranty as specified/offered by the OEM at site for the item supplied.
- 4.4 The Agency will supply Technical Manual and Operating Manual with the item.

5. **SUBMISSION OF BIDS**

- 5.1 The agency should submit bids in two parts, one the **Technical Bid** in **Annexure I** and other the **Financial Bid** in **Annexure II**. Technical and Financial bids should be placed in two separate envelopes super scribed accordingly. Both these envelopes should be placed inside a large sealed cover super scribed as “**Tender Notice for Supply of LED Television to RSTV**”. The tender should be addressed to **Additional Director, Rajya Sabha Television, 3<sup>rd</sup> Floor, Talkatora Stadium Annexe Building, New Delhi – 110001**. It may be dropped in the drop-box latest by **5.00 p.m. on or before 19 September, 2019** at the above mentioned address or may be sent by courier/registered/speed post so as to reach RSTV by **5.00 p.m. on or before 19 September, 2019**. Any bid received after the prescribed deadline will be rejected.
- 5.2 The technical bid should be given in the proforma attached as **Annexure- I** and should be accompanied by earnest money deposit (EMD) of **Rs. 21,000/--(Rupees twenty one thousand only)**. The EMD should be submitted in the form of a Demand Draft/Pay Order drawn in favour of “**Drawing & Disbursing Officer, Rajya Sabha Television**” payable at **New Delhi**. Tenders without EMD will be rejected. Bidders who are exempted under Rule 170 of GFR, 2017 need not submit EMD. EMDs of the unsuccessful bidders will be returned after the completion of the tender process. EMD of successful bidder(s) will be retained as security till 60 days after the completion of supply of the specified item. No interest shall be paid on the EMD. In case the successful bidder withdraws or if details furnished by any bidder in the bid are found to be incorrect or false during the tender process, his EMD will be forfeited.
- 5.3 Financial Bid should be given in the proforma attached as **Annexure-II**. Rates quoted should include delivery of item on site.
- 5.4 There should not be over-writing or correction or cutting in the bids and each page of the Technical Bid as well as Financial Bid should be signed by an authorised representative. The agency should avoid submitting irrelevant documents.

5.5 Firm rates/charges should be quoted in Indian Rupees both in figures and words and should be valid for **180 days** from the date of opening of the bids. Rates / charges should be inclusive of any other incidental charges. However, rate of GST should be mentioned separately.

6. **PRE-BID MEETING**

A pre-bid meeting will be held at **4.00 p.m** on **09 September, 2019** in the office of RSTV, 3<sup>rd</sup> Floor, Talkatora Stadium Annexe Building, New Delhi where the intending bidders may seek any clarifications and visit RSTV office to have first-hand information about the requirements of RSTV. The intending bidders are requested to make it convenient to attend the pre-bid meeting so that there may not be any communication gap and they may understand the requirement of RSTV.

7. **OPENING OF BIDS**

7.1 Technical Bids will be opened at **5 p.m. on 20 September, 2019 at RSTV office, Talkatora Stadium Annexe Building, New Delhi-110001** in the presence of the bidders or their representatives.

7.2 Financial Bids of only such bidders will be opened who are found eligible in Technical Bid. Time and date of opening of the Financial Bids will be informed to the agencies which are found eligible in the Technical Bid.

8. **TERMS OF PAYMENT**

8.1 The agency shall submit the bill on satisfactory delivery, installation and working of the item along with the satisfactory working certificate obtained from Technical Department of Rajya Sabha Television. 90% payment will be released to the agency within 30 days from the date of submission of the bill(s).

8.2 RSTV will withhold 10% of the total value of the tender as performance security. Performance Security should remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the supplier including warranty obligations.

9. **REJECTION OF BIDS**

9.1 Canvassing by the agencies in any form, unsolicited letters and post tender correction may lead to rejection of Bid with forfeiture of EMD. Conditional tenders will be rejected.

9.2 Bids of the firms not fulfilling any or all of the conditions given in this notice are liable to be rejected.

9.3 RSTV reserves the right to cancel/reject any or all tenders without assigning any reason thereof.

10. **PENALTY CLAUSE**

Time is the essence and the agency should stick to the prescribed time schedule. In case of late delivery of the item, the agency shall be liable to pay penalty @ 0.5% of the order value per week of delay or part thereof, upto a maximum amount of 5% of order value, after which the order is liable to be cancelled.

11. **INDEMNITY**

The successful agency shall at all times indemnify RSTV/Rajya Sabha Secretariat towards any loss/damage caused or any claim raised against RSTV/Rajya Sabha Secretariat by any party/third party in relation to supply of the item. The successful bidder shall be liable, in accordance with the Indian Laws and Regulations for any accident or damage incurred or claims raised against RSTV/Rajya Sabha Secretariat during the period of delivery of the item. The successful bidder shall also provide all insurance, including third party insurance as may be necessary to cover the risk. No extra payment would be made to the successful bidder on this account.

12. **ARBITRATION**

All the disputes and differences arising out or in any way touching or concerning this tender shall be referred to the sole arbitrator appointed by the Secretary-General, Rajya Sabha. There will be no objection that the person so appointed is or was in the employment of the Rajya Sabha Secretariat and as an employee of the Rajya Sabha Secretariat had during the course of his duties expressed views on all or any of the matter of difference or dispute. The award of such arbitration shall be final and binding on both the parties. The arbitration proceedings shall be held in Delhi.

13. **JURISDICTION**

The Courts at New Delhi will have the sole and exclusive territorial jurisdiction over any dispute or difference in connection with this tender.
