**CORRIGENDUM/ADDENDUM TO THE TENDER NOTICE FOR MARKETING,  
DISTRIBUTION AND SELLING OF A FEATURE FILM BEING PRODUCED BY  
RAJYA SABHA TELEVISION**

With reference to the tender notice No. RS.1/46/2014/Admn. dated 10 March, 2017, for hiring the services of an agency for Marketing, Distribution and Selling of feature film “Raag Desh – The Birth of a Nation” being produced by RSTV, a pre-bid meeting was held on 22 March, 2017, at 4:00 p.m. at 3<sup>rd</sup> floor, Talkatora Stadium Annexe Building. In pursuance of the meeting, following amendments are made to the tender notice:

**i) Para 3.3 of the tender may be read as under:**

The bidder should have had an average turnover of **Rs.75 crore or above** during the last three financial years 2013-14, 2014-15 and 2015-16. The average will be taken by totalling the turnover in these three years & dividing by three (3). **Attested copies of Income Tax Returns, Profit & Loss A/c and Balance Sheets for these financial years should be enclosed with the technical bid.**

**ii) Para 10 of the tender may be read as under:**

The successful bidder will have to provide a Bank Guarantee equal to the amount of the bid and the money to be released to the bidder. This Bank Guarantee will be the Performance Security for the due performance of the contract. The said Bank Guarantee will be from a scheduled commercial bank and valid for a period of **12 months** from the date of award of bid or completion of project, whichever is later. In case the bidder fails to fulfil any of the conditions or offers made in the bid submitted by him or any of clauses of the tender, the said Bank Guarantee will be liable to be forfeited.

**Technical Bid**

**i). Point 10 of the Technical Bid may be read as under:**

**Release Plan** - The bidders will have to submit a release plan with minimum of 1 (one) week guarantee

**ii). Point A.1 of the Technical Bid may be read as under:**

**Circuit wise number of screens** - The bidder will have to submit a release plan showing the number of screens (minimum 700 screens) offered in each of the trade circuits.

**iii) Point B.1 and B.6 of Technical Bid:**

**Number of shows and minimum percentage to be scored for one week guarantee as amended in Point 10 of Technical Bid.**
